Title of the course: Comparative Migration and Immigration Policy

General information and objective of the course

Migration and immigration are key-issues within the institutional agenda of contemporary liberaldemocracies. The aim of the course is to enable students to analyse the themes and questions related to migration and immigration through the lenses of political science.

The course will focus on the policies adopted by the States and International Organizations since the beginning of the Nineties. The research questions to be addressed are the following: 1) what do we study when facing the problems of immigration?; 2) which are the main consequences of migration and immigration in terms of intra and inter-State politics and policies? 3) do migration and immigration need to be studied through new concepts and approaches?

Particular attention will be devoted to the multi-level settings that characterize migration and immigration policies and to the dynamics of the relations between actors operating at different territorial levels. To this aim, the course will help students to identify and compare the main guidelines and policies adopted by international organizations and States, to assess similarities and differences in policy planning, implementation and evaluation in the field.

Drawing on theories and methods of comparative politics, the course will provide students with a tool-box oriented to the analysis and planning of interventions in the migration/immigration policy domain. This expertise shall consent students to take up careers in international organizations (both scientific and humanitarian) as well as in the field of cultural mediation.
