### **General information and objective of the course :**

The objective of the course is to introduce the student to main debates and issues characterizing the perspective of political ecology.

### **Course Descriptions:**

This course proposes an introduction to political ecology as an interdisciplinary field characterized by a focus on the political dimension of ecological issues. It will present the characteristics of an approach centred on environmental justice will be and the main contributions to political ecology have, such as Eco Marxism, ecofeminism and decolonial studies. A genealogical approach will be adopted in order to understand the current conjuncture, with particular attention to new « prefigurative » mobilizations, the narration and discussions on the Anthropocene, the biopolitics and emerging tendencies in the valorization of nature and anticipatory government of incertitude. Particular attention will be dedicated to conflicts surrounding the extraction of natural resources. The presentation of particular ethnographic case-studies will allow to exemplify and discuss the theoretical contributions presented.

### **Methodology :**

The course will take place in the form of frontal lessons, occasionally supported by material such as slides, videos and website analysis, as well as by expert participation, in particular that

### **Pre-requisites, exams and assessment :**

*Pre-requisites:*

*Assessment:*

The course assessment is composed by a written and an oral exam.

The written exam consists in a test with open questions, to be carried out in about one hour. The results are valid only for the exam session in which the test is taken. The professor evaluated the completeness and congruence of the answers to the questions, in order to admit to the oral test.

The oral exam consists in a discussion of the written test results and in a conversation that mainly centers on the optional text chosen by the student. In this case too the completeness and congruence of the answers provided will be evaluated by the professor.
